- Speaking in respectful tones, refraining from the use of vulgar or derogatory language and dressing appropriately
- Resolving conflicts in a respectful, honest, and caring manner
- Respecting others by refraining from intimate behavior in public
- Respecting the property of others
- Creating a safe, caring, environment free of weapons and firearms
- Participating in programs to build healthy spirit, mind and body
- Never engaging in the use, sale, dispensing or possession of illegal drugs or the unsanctioned use of alcohol on the YMCA premises

## **Island of Hawaii YMCA MEMBERSHIP Release and Waiver of Liability and Indemnity Agreement**

**In consideration for being permitted to utilize the facilities, services, and programs of the Island of Hawaii YMCA for any and all purposes, including but not limited to observation or use of facilities, equipment, participation in any program affiliated with the Island of Hawaii YMCA.**

Hereby acknowledges, agrees, and represents that I have immediately upon entering or participating will inspect and carefully consider such premises and facilities, located at 300 West Lanikaula Street, Hilo, Hawaii 96720, or any program originated at the YMCA, however located in the community.
